There is a one time non-refundable \$150.00 fee charged for accepting a pet and is due and payable with your first month's rent. We must approve pets and applicant must sign a pet agreement included in Lease. NO PETS ARE ALLOWED UNLESS the above fees are paid and a Pet Agreement is executed with Fan Apartments, Inc. NO MORE THAN 2 PETS ARE ALLOWED! NO PIT BULLS! (As per our Insurance company. SORRY!)
